CORRIGENDUM

The following corrigendum is hereby issued to Tender Enquiry No.B-31/SPG-Prov/2017(44)-**2924** dated **22.05.2018** for procurement of **15 Nos. Explosive Detectors** on Open Tender (e-procurement) Basis.

2. With reference to above mentioned Tender Enquiry, the following modifications have been made in tender conditions, which are as under:-

Clause - 2 (a) (ii) at page-2 of TE.	The bidder should have an average annual turnover of at least Rs. 400.00 Lac during the preceding three financial years each. Copies o audited annual accounts or a certificate from Chartered Accountant should be uploaded.	The bidder should have an average annual turnover of at least Rs. 400.00 Lac during the preceding three financial years i.e. 2015-16, 2016-17 & 2017-18. In this regard, copies of relevant annual account (audited balance sheet and profit-loss account only), duly authenticated by Chartered Accountant/Cost Accountant should be uploaded.
Clasue- 2 (b) (iii) at page-2 of TE	India agent must submit documents of its own firm to meet pre-qualification criteria. Copies of financial statements/supply order of their principals will not be considered.	Authorized Representative: Bids of bidders quoting as authorized representative of a principal manufacturer would be considered to be qualified, provided; a) Their principal manufacturer meets all the criteria above without exemption, and b) The principal manufacturer furnishes a legally enforceable tender-specific authorization in the prescribed form assuring full guarantee and warranty obligations as per the general and special conditions of contract, and c) The bidder himself should have been associated, as authorized representative of the same or other Principal Manufacturer for some set of services as in present bid (supply, installation, satisfactorily commissioning after sales service as the case may be) for same or similar "Product" for preceding three years. d) Representative to get themselves registered with SPG.

Such tenderer must submit a copy of registration with the NSIC/MSME/ Startup recognition from DIPP with e-bid.
Clause- 3(3) at page-3 of TE	Evaluation of price bid: L-1 will be decided by taking into account the total cost including basis price of equipment, installation & commissioning, freight/ insurance and excluding statutory duties & taxes.	L-1 will be decided by taking into account the total cost of the equipment including statutory taxes & duties, and estimated LC/wire transfer charges. Custom duties will be part of statutory taxes/duties.
Clause- 3(5)	Cost of stores may be quoted as per Annexure-VI under commercial bid.	Price Schedule (Annexure-VI) has been amended and revised price schedule is enclosed herewith to quote the cost of equipment accordingly.
