## 1. Introduction

(A) The Special Protection Group (Cabinet Secretariat), SPG Complex, Sector 8, Dwarka, New Delhi-110077 intends to e-procure, installation & commissioning of Perimeter Intrusion Detection System (PIDS) at PMH Complex covering perimeter of 2800m (approx) as per details enclosed with this tender document.

- (B) On line offers in TWO BID SYSTEM (i.e. Technical bid and Commercial /Financial bid) are invited from the manufacturer of major components of PIDS.
- (C) The tender document may be read carefully. Offers received without requisite documents/certificates as asked under pre-qualification criterion and other clauses of tender, are liable to be rejected.
- (D) Bidders are advised to keep note of time required for preparation of Entry pass at the gate and come to deposit EMD well in advance so as to reach well before specified time of closing.

## 2. Pre-qualification criteria

Documents connected with fulfillment of pre-qualification criteria must be furnished with technical bid.

Pre-qualification criteria for bidders are as under:-

	Domestic Tenderers :-
(i)	The bidder should be a registered firm/ <u>concern</u> or a company registered under the Companies Act, 1956 or registered with various taxation authorities. Copies of registration certificate should be uploaded alongwith Technical Bid.
(ii)	The bidder should have an average annual turnover of at least Rs 300.00 Lac during the preceding three financial years. Copies of audited annual accounts or a certificate from Chartered Accountant should be uploaded.
(iii)	The bidder firm should have experience of at least such one project executed with Govt./PSU/Autonomous body during last three years. Copy of supply order of same project indicating value should be uploaded.

## 3. Terms &amp; Conditions of the Tender

(1)	<b>Earnest Money Deposit (EMD) :</b> The Bidders are to deposit an amount of Rs. 2,00,000/- in the form of Demand Draft/Fixed Deposit Receipts/Bankers Cheque/Bank Guarantee drawn in favour of " <b>Director of Accounts Cabinet Secretariat, Spl Wing, SPG</b> " payable at New Delhi, towards the EMD along with the tender. Earnest Money should reach to O/o AIG (Prov), SPG on or before end of date of e-bid submission, failing which offer will be liable for rejection. Bidders, however, have to attach scanned copies of Earnest Money documents alongwith their e-tender. The EMD of the unsuccessful bidders will be returned after finalization of the tender. The EMD of the successful bidder will be forfeited if it fails to execute the contract or fails to submit performance security as requested in terms of TE/AT. The EMD will not carry any interest. The tenders without accompanying the EMD amount will be summarily rejected. Firms who are registered with DGS&D/NSIC/MSME irrespective of the stores for which they are registered, are exempted from payment of EMD. Such tenderer must submit a copy of registration with the DGS&D/NSIC/MSME with e-bid.
(2)	FOR Price of the Store, freight charges, GST, Commissioning & Installation charges etc. should be indicated separately. Freight charges will be re-imbrued as per actual on submission of original bills.
(3)	Evaluation of price bid : L-1 will be decided by taking into account the basic price of equipment, installation & commissioning, freight /insurance, commission and CAMC charges excluding statutory duties and taxes.
(4)	Cost of stores may be quoted as per annexure-VI under commercial bid.
(5)	<b>Performance Security/Security Deposit:</b> The successful bidder is required to deposit 10% of the contract value within 30 days from the date of issue of AT (purchase order) in the form of Demand Draft/Fixed Deposit Receipts/Bankers Cheque/Bank Guarantee from any scheduled commercial bank in India in favour of " <b>Director of Accounts Cabinet Secretariat, Spl Wing, SPG</b> " payable at New Delhi, towards the Security Deposit, which must be valid for a period 60 days beyond completion of all contractual obligations, including warranty period. In case of performance Security in the form of BG, it is to be submitted by the bidder in the form at <b>Annexure-IV</b> . If the successful tenderer fails to submit performance security within the prescribed time, its EMD will be forfeited and contract may be cancelled unilaterally. PBG will be released only after meeting all the contractual obligations including warranty period.
(6)	<b>Validity of Offer :</b> Offer should be valid for at least <b>six months</b> from the date of opening of technical bid.

(7)	<b>Payments Terms:-</b> All payments will be made against delivery of Stores in full, good and satisfactory conditions, successful installation & commissioning of systems at both sites and meeting all the terms and conditions of Tender Enquiry. All Payments will be made after applying the tax deductions at source, if applicable.
(8)	<b>Place of installation and commissioning:</b> Installation and commissioning of PIDS are to be carried out at PMH Complex, New Delhi.
(9)	<b>Period of Installation &amp; Commissioning:</b> Delivery period will be <b>12 Weeks</b> from the date of issue of supply order/AT for supply including installation & commissioning of the system.
(10)	<b>Inspection:-</b> Inspection of the system will be done before acceptance at the place of installation and commissioning i.e PMH Complex, LKM, New Delhi.
(11)	<b>Warranty:</b> Warranty will be for <b>24 months</b> from the date of successful installation and commissioning and testing of PIDS.
(12)	<p><b>AMC :</b> Comprehensive Annual Maintenance to be done by the supplying firm for a period of five years after completion of warranty period as per draft agreement at Annexure- "VII" to be attached. Rate of CAMC for five years must be quoted in the price bid. The decision regarding entering into CAMC after above period will depend upon the future review of the requirement by SPG. However, it will be at the discretion of SPG, to go for CAMC or otherwise. Rate of CAMC must be quoted in the price bid which will be taken into account for determining I-1.</p> <p>The supplying firm will submit Performance Bank guarantee @ 10% of annual maintenance contract value as per provision of GFR. This PBG must be submitted at least one month prior to completion of warranty period and same will remain valid for a period 60 days beyond completion of all contractual obligations pertaining to CAMC.</p>
(13)	<b>Extension of Delivery period-</b> If the supplier is unable to complete the supply within the stipulated delivery period for which the supplier is responsible, it (supplier) is required to request for extension of delivery period. If the purchaser agrees to extend the contractual delivery schedule, the same will be done by issue of an amendment to the contract with suitable denial clauses and with imposition of liquidated damages for delay. The amendment letter will contain, inter alia that, in addition to imposition of liquidated damages, no extra price or additional cost for any reason whatsoever beyond the contractual cost will be paid to the supplier for the delayed supply; at the same time, if for any reason, whatsoever the cost of the goods to be supplied/services to be performed by the supplier decreases that benefit will be passed on to the purchaser. Supplier is required to submit unconditional acceptance of the amendment by a specified date mentioned therein and if the supplier does not agree to accept the amendment letter, further action will be taken in terms of the contract.

(14)	<b>Despatch of Goods after expiry of Delivery Period-</b> As per the contract terms, the supplier is not to supply the goods when there is no valid delivery period. In case the supplier makes any supply after expiry of delivery period, the purchaser/consignee can reject the supplies and inform the supplier accordingly; the purchaser shall also have the right to cancel the contract (w.r.t. unsupplied goods) in terms of the contract.
(15)	<b>Franking Clause</b>
	<p><b>a)Franking Clause in the case of Acceptance of Goods:-</b></p> <p>"The fact that the installation &amp; commissioning have been inspected after the due date of installation &amp; commissioning and passed by the Inspecting Officer will not have the effect of keeping the contract alive. The goods are being passed without prejudice to the rights of the purchaser under the terms and conditions of the contract".</p> <p><b>b)Franking Clause in the case of Rejection of Goods:-</b></p> <p>"The fact that the installation &amp; commissioning have been inspected after the due date of installation &amp; commissioning and rejected by the Inspecting Officer will not bind the purchaser in any manner. The goods are being rejected without prejudice to the rights of the purchaser under the terms and conditions of the contract".</p>
(16)	<b>Liquidated Damages :</b> If the Contractor fails to deliver the Stores & complete the installation & commissioning of the system at both site within the prescribed installation & commissioning period, the Purchaser has the right to recover liquidated damage equivalent to 0.5% per week or part thereof of the contract value from the Contractor subject to a ceiling of 10% for delayed supplies/services/ installation & commissioning.
(17)	<b>Token Liquidated Damage :</b> There may be situations when charging full Liquidated Damages may not be justified as the reasons for delay in delivery by the supplier may be largely due to circumstances well beyond under his control but nevertheless these may not considered adequate to waive off liquidated damages altogether or there may be such deficiencies in service for which quantification may not be feasible and no other remedy may be available. In such cases, at the sole discretion of the purchaser, Token Liquidated Damages up to 10% of the normal Liquidated Damages will be imposed by the purchaser, i.e., 0.05% per week or part thereof subject to the maximum of 1% for delayed supplies/services/ installation & commissioning.
(18)	<b>Demonstration -</b> The bidding firm must give complete demonstration of the product bidding for at SPG Complex, Dwarka, New Delhi-77 by setting a demo model of minimum 25m length including all types of sensors and a display (not at line of sight from PIDS) to see the effectiveness of system within 45 days from the date of opening of technical bid. Generally no extension of time will be granted. The tendering authority will be under no obligation to bear any charges of firm to this effect.

(19)	<p><b>Cancellation of Contract:-</b> The purchaser may, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, terminate the contract in whole or in part:-</p> <p>a) If the supplier fails to deliver any or all of the stores within the time period(s) specified in the contract, or any extension thereof granted by the Purchaser; or</p> <p>b) If the supplier fails to perform any other obligation under the contract within the period specified in the contract or any extension thereof granted by the purchaser.</p> <p>In the event the purchaser terminates the contract in whole or in part; the purchaser may take recourse to any one or more of the following action.</p> <p>a) the Performance Security is to be forfeited;</p> <p>b) the purchaser may procure, upon such terms and in such manner as it deems appropriate, stores similar to those undelivered, and the supplier shall be liable for all available actions against it in terms of the contract.</p> <p>c) however, the supplier shall continue to perform the contract to the extent not terminated.</p>
(20)	<p><b>Contract termination / splitting / rejection clause:</b></p> <p>SPG reserves the right to terminate the contract, split orders, accept or reject any quotation alter any or all of the terms and conditions any time if the execution of work is unsatisfactory or the time schedule is not strictly adhered to. The decision of SPG in respect of evaluation of bids and / or award of contract shall be final.</p>
(21)	<p>SPG reserves the right to reject any or all tenders without assigning any reason.</p>
(22)	<p>Conditional offers and non-conformity of the terms and conditions and offers not submitted as per the details, will be rejected.</p>
(23)	<p>It is the responsibility of the successful bidder to pay all statutory taxes i.e. GST etc. relating to the contract with the concerned Govt. authorities. If however, the supplier receives any refunds of such duties and taxes subsequently, he will forthwith deposit the purchaser's share (for which he has already been paid) immediately, failing which suitable action will be taken against the supplier as per the law in force.</p>
(24)	<p>The firm should certify that OEM as well as bidding firm has not been blacklisted / debarred from any Govt organisation/PSU.</p>
(25)	<p>Clarification regarding Tender documents: Ordinarily no occasion for clarifications should arise as all matters are clarified in the tender document itself. However, the clarifications, if any, the same may be sought during pre-bid conference only by the bidder firms and decision taken thereon by SPG will be final. Thereafter no representation will be entertained.</p>



(26)	<p><b>Amendment of Tender Document:</b></p> <p>At any time up to the last date for receipt of bids, SPG may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder, modify the Tender document by an amendment and extend date of submission of bids.</p> <p>The amendment, if any, will be notified through CPP Portal.</p>
(27)	<p>The information to be submitted by the bidder should be as per the description given in this document.</p>
(28)	<p><b>No commitment to accept best or any other offer :</b> SPG shall be under no obligation to accept the best or any other offer received in response to this tender notice and shall be entitled to reject any or all the bids including those received late or incomplete bids without assigning any reason whatsoever. SPG will not be obliged to meet and have discussions with any bidder, and / or to listen to any representation. While the above procedures lay down the overall guidelines, SPG reserves the right to select the bidder based on other parameters at its discretion.</p>
(29)	<p>There should be no overwriting in the bidder's offer. If required, by scoring out entries and writing afresh, the bidder can make corrections. The initials of the bidder's authorised person and the seal of the bidder's company must verify each correction. All rates given in this tender must be expressed as numerals and words. In case of any discrepancies, the price in words will be taken as correct.</p>
(30)	<p>No alteration in the terms and condition or offer will be allowed during the consideration of the tender. However, SPG reserves the right to negotiate the offer with the successful bidder before signing of the contract.</p>
(31)	<p><b>Non-Disclosure Condition:</b> The firm is required to furnish the following undertaking in original on its official stationery duly signed and stamped by an authorized signatory. This document should be supported by some documentary evidence in order to establish that the signatory has sufficient administrative and/or legal authority within the company to enforce this condition effectively</p> <p><b>I/We hereby assure and undertake that no part of this document and final contract with SPG shall ever be revealed to any third party, domestic or foreign, in any form, oral or written, partial or full, technical or financial, without obtaining prior written permission of SPG or unless required by the law of the land and it is my/our responsibility to take necessary measures, legal or otherwise, to ensure that this condition is honoured by all including our local representative/s, distributor/s or agent/s, if any.</b></p>

(32)	<b>Anti-Corruption Notification:</b> Giving and taking bribe is a serious offence in the Republic of India. It is therefore unambiguously notified to all concerned that any money or favour demanded by anyone in any form or kind, in connection with your present or future business with SPG, on behalf of the organization or any individual working in the organization or anywhere else, shall be totally unfounded, baseless and illegal. Such suggestion or demand shall be refused forthwith and reported immediately to SPG.
(33)	<b>Arbitration:</b> In case of any dispute or <u>difference</u> arising out of or in connection with this contract, the authorized officials of both the parties will try to resolve the matter through mutual discussions and in the event of there being no resolution; the matter shall be referred for arbitration to a sole arbitrator to be appointed by the SPG/Cabinet Secretariat. The arbitration and Conciliation Act, 1996 will be applicable to the arbitration proceedings and the venue of the arbitration shall be at New Delhi. The award of the arbitrator shall be binding on both the parties. The cost of arbitration including the fees of the Arbitrator shall be borne by both the parties equally and will be adjusted, if required, after the award of arbitrator. Each party shall be responsible for its own costs and professional fees, if any.
(34)	<b>Jurisdiction of Courts in case of disputes:</b> All matters and disputes arising from, relating to or concerning the contract shall be subject to the jurisdiction of the courts in New Delhi.
(35)	<b>Force Majeure:</b> The bidder shall not be liable for forfeiture of its performance security, termination of contract, if and to the extent that its delay in performance or other failure to perform; obligations under the contract is the result of an event of Force Majeure. For purposes of this clause ' <i>Force Majeure</i> ' means an event beyond the control of the bidder and not involving the bidder's fault or negligence and not foreseeable. Such events may include but are not limited to, acts of God or of public enemy, acts of Government of India in their sovereign capacity, acts of war, fires, floods etc. If a Force Majeure situation arises, the bidder shall promptly notify SPG in writing of such conditions and the cause thereof within ten calendar days. Unless otherwise directed by purchaser in writing, the bidder shall continue to perform its obligations under the Contract so far as it is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event. In such a case, the time for performance shall be extended by a period(s) not less than the duration of such delay. If the duration of delay continues beyond a period of three months, purchaser and the vendor shall hold consultations with each other in an endeavour to find a solution to the problem. Notwithstanding the above, the decision of purchaser shall be final and binding on the vendor.

(36)	<p><b>Acceptance of Terms &amp; Conditions :</b>  The e-bidders should specifically mention that all the terms and conditions described in this tender are unconditionally acceptable. SPG reserves the right to accept/reject any/all the bids.</p>
(37)	<p>The terms and conditions (i.e. all the pages of Bid documents) must be initialled on each page (right bottom corner) and signed in full along with date and seal affixed at the last page. Scanned copy be uploaded with technical bid documents.</p>
(38)	<p><b>Other terms &amp; Conditions :</b></p> <ul style="list-style-type: none"> <li>a) All major systems/ subsystems of PIDS should be of <b>Indian</b> make. The make/model for all major system/ subsystem should be reflected in the tender document (except for items not manufactured in India).</li> <li>b) Repairs during and CAMC period should be carried out at the place of installation. If a replacement of component is required to be carried out, its replacement will be provided by firm in advance. In case of fault in PC/Workstation, its hard-disk will not be provided to the firm for carrying it out of SPG site for repair.</li> <li>c) Essential spares should be available locally.</li> <li>d) Maintenance &amp; service training for 10 SPG officers be provided by the firm on free of cost basis at SPG site.</li> <li>e) Engineering and maintenance manual is to be provided (hard and soft copy both).</li> <li>f) List of deliverables as mentioned under technical specifications must be attached with Technical Bid and also to be presented to TFC members by the authorized signatory of the firm at the time of evaluation.</li> <li>g) List of spare parts must be attached with Technical bid.</li> <li><b>h) Technical Specification will be obtained by the firm from Technical Branch separately.</b></li> </ul>

### Technical Bid

## 1.0 Scope

1.1 M/s \_\_\_\_\_, by its acceptance hereof agrees to undertake the maintenance of all components supplied with Perimeter Intrusion Detection Systems as per Annexure A (details of components to be mentioned at Annex-A), will be covered under this maintenance contract for PM House complex at New Delhi.

1.2 M/s \_\_\_\_\_ shall be responsible to provide services round the clock, 365 days a year, carrying out preventive maintenance and upkeep of the systems/subsystems maintenance and repairs against all failures of Perimeter Intrusion Detection Systems as mentioned in para 1.1 above.

1.3 M/s \_\_\_\_\_ shall be responsible to arrange and supply the original equipments manufactured spares wherever and whenever required for providing back-to-back AMC support. M/s \_\_\_\_\_ shall guarantee availability of Spares during the tenure of AMC.

## 3.0 Breakdown Maintenance

3.1 In view of the urgency of the work, the firm shall ensure that the breakdowns of the system are attended on urgent basis and the maintenance engineer will attend the breakdown on the same day. The firm shall ensure that breakdown will be rectified within 6-8 hours from the time of complaint to the contractor.

3.2 No extra charges will be levied on SPG in case machine/equipment is to be transported from SPG location to the Office/workshop of the firm for repairs and bringing the same back, duly rectified.

#### **4.0 Preventive Maintenance**

4.1 The engineer from the AMC firm will visit the site at least once every month for carrying out preventive maintenance to reduce system breakdown.

4.2 A preventive maintenance schedule will be drawn in mutual consultation with AIG (Tech), SPG and adhered to strictly. The engineer from the firm will furnish the job certificate duly certified by the user in token of satisfactory performance of the system and on the production, subsequent payment would be released.

4.3 During the monthly inspection/preventive maintenance service of the equipment, it will be thoroughly cleaned, tested, repaired and kept in working condition.

4.4 If the PIDS or a component of it is rendered un-operational because of damage due to mishandling, tempering, accident, negligence, misuse or abuse, AC voltage fluctuations, fire or other acts of Nature etc. the contractor reserves the right to charge the customer for repair thereof i.e. for material as well as labour. However, the decision to assess the cause of damage will be decided jointly by the firm and SPG.

#### **5.0 Replacement of Parts**

## **10.0 Force Majeure –**

Subject to the clauses herein above provided, if any suit or proceedings to enforce the rights of either parties hereto under this arrangements, only courts at Delhi shall have exclusive jurisdiction and both parties hereby expressly agree to submit to the jurisdiction of such court.
