- 6. The successful bidders shall not be charge any amount from the consumers in the complex towards installation charges of Cable TV.
- 7. The rates quoted per connection shall not be liable for upward revision for first 03 years from the commencement of the contract.
- 8. It shall not be binding on residents to utilize the services of the network.
- 9. The facility shall be exclusively for SPG Complex and the Cable TV services provider shall not be permitted to provide connection to anyone outside complex.
- 10. The successful bidder shall be liable to give satisfactory service to the residents and will be responsible for collection of Monthly charges directly from the residents fixed as per the terms and conditions.

- 17. The contract shall also be liable to be terminated in the event of non payment of Licence fee of the shop on time.
- 18. The L1 will be decided on the basis of the monthly subscription charges per month for each connection quoted by the bidders.
- 19. The licence for Cable TV Network / Shop will normally be allotted to the bidder found suitable by a Board of Officers. Director, SPG reserves the right to reject this offer or all the offers without assigning any reason for the same.
- 20. The monthly subscription charges offered in the tender should be in round figure of full rupees and not in paisa. If any such tender is received and it is decided to accept the tender, the allotment will be made by rounding off 50 paisa and above as one rupee and ignoring below 50 paisa.
