Director, SPG on behalf of the President of India invites applications of tenders in sealed covers up to 1400 hrs on 23/04/2019 for allotment of shop in SPG Shopping Complex, in Sector-8 of Dwarka New Delhi as per details given below on monthly licence fee basis. The tenders will be opened at 1600 hrs on the same day.

General Terms

- i) Shop in Col. No.2 is to be used for the purposes shown in Col. No.4. and not for any other purposes than what is stipulated in the tender notice.
- ii) The bidder will be required to deposit three months licence fee offered by him through Bank draft drawn in favour of DIRECTOR OF ACCOUNTS, CABINET SECRETARIAT (SPL. WING) SPG NEW DELHI as earnest money deposit. This shall be refunded in case of unsuccessful bid. The licence fee would be adjusted towards security deposits in case of successful bidding.
- iii) The successful bidder in the open tender would be allotted the shop initially for a period of 3 years on the basis of stipulated terms and conditions which will be given at the time of award of allotment. Preference will be given to bidders having experience in the relevant field. A Board of officers shall assess rates quoted before a decision is taken for allotment.
- iv) The allotment of shop shall be subject to increase in the licence fee (rent) at the rate of 15% of the preceding month's rate after every three years.
- v) Physical possession of the shop shall be handed over to the successful bidders. In case the selected bidder does not take possession of the allotted premises within one month, the shop shall be offered to next bidder(s). In such an event the earnest money deposited by the selected bidders shall stand forfeited.
- vi) The Director, SPG reserves the right to reject any or all of the bids without assigning any reason thereto.
- vii) All Tenders shall be subject to terms and conditions attached with the Tender form.

GENERAL TERMS AND CONDITIONS GOVERNING TENDERS FOR ALLOTMENT OF SHOP UNDER THE CONTROL OF DIRECTOR, SPECIAL PROTECTION GROUP (CAB. SECTT).

1.	The shop will normally be allotted to the bidder found suitable by a Board of Officers but the Director, Special Protection Group, Cabinet Secretariat reserves the right to reject this offer or all the offers without assigning any reason for the same. Documents related to trade experience may be attached with the tender form.
2.	The monthly licence fee offered in the tender should be in round figure of full rupees and not in paisa. If any such tender is received and it is decided to accept the tender, the allotment will be made by rounding off 50 paisa and above as one rupee and ignoring below 50 paisa.
3.	The successful bidder will have to execute a Licence Deed with Govt. of India and he will have to deposit one month licence fee in advance & security deposit equivalent to 6 months licence fee within 8 days from the date of issue of the allotment letter. He will also submit two recent Passport size Photographs , copy of permanent address proof and Caste certificate duly attested by a Gazetted Officer or a 1 st class Magistrate.
4.	The bidder must not be a minor.
5.	The partnership firms and societies are not eligible.
6.	Govt. Servant and employees of local bodies are not eligible.
7.	Person /bidder will apply for shop in one tender form.
8.	The tender should be submitted in sealed envelope super scribed “(Tender for allotment of Shop No. 05)” and be deposited in the Tender Box placed at the Reception, Adm. Block, SPG Complex, Sector-8, Dwarka, New Delhi-77 before 1400 hrs on 23/04/2019 . Tenders received after 1400 hrs on 23/04/2019 shall not be accepted. Tender envelope without the proper superscription mentioned above or without seal shall also not be accepted.
8a	A Demand Draft from any Scheduled Bank in favour of “Director of Accounts, Cabinet Secretariat (Special Wing) SPG” payable at New Delhi for an amount equivalent to three months licence fee offered by the bidder should be enclosed with the tender form as earnest money. No tender shall be considered valid without such Demand Draft.
8b	The amount of the earnest money in respect of the successful bidder will be adjusted against the amount of the security deposit required as per clause-3 above. The earnest money of unsuccessful bidders will be refunded after completion of the tender formalities.
8c	The earnest money of the second and third highest bidders (H2 and H3) will, however, be refunded only after the shop is allotted and accepted by the highest bidder.
9.	Failure to accept allotment by complying with all the requirements of allotment letter within the stipulated period mentioned in Para 3 above shall entail forfeiture of the aforesaid earnest money in full .
10.	The tenders will be opened at 1600 hrs on 23/04/2019 at SPG Complex, Dwarka. The Bidders can be present at that time in person or through representative duly authorized in writing, if so desire by them.
11.	Bidders will not be allowed to withdraw their offer up to 45 days from the date of opening of tenders. In case they do so, it shall entail forfeiture of the aforesaid money in full.
12.	The running of shop will be subject of laws and bylaws of local bodies of the area.
13.	Successful bidder will not sublet awarded shop to anyone.
14.	The present shopkeeper will not be given bidding opportunity.
15.	The bidder is required to submit a “Character & Antecedents Verification Form” in prescribed proforma <i>(to be provided with Tender Form)</i> duly verified by the SHO of concerned Police Station. Without enclosing duly verified “Character & Antecedents Verification Form” the bid is liable to be rejected.
