General Terms

i) Shop in Col. No.2 is to be used for the purposes shown in Col. No.4. and not for any other purposes than what is stipulated in the tender notice.

II) The bidder will be required to deposit three months licence fee offered by him through Bank draft drawn in favour of <u>DIRECTOR OF ACCOUNTS, CABINET SECRETARIAT (SPL. WING)</u> <u>SPG NEW DELHI</u> as earnest money deposit. This shall be refunded in case of unsuccessful bid. The licence fee would be adjusted towards security deposits in case of successful bidding.

iii) The successful bidder in the open tender would be allotted the shop initially for a period of 3 years on the basis of stipulated terms and conditions which will be given at the time of award of allotment. Preference will be given to bidders having experience in the relevant field. A Board of officers shall assess rates quoted before a decision is taken for allotment.

iv) The allotment of shop shall be subject to increase in the licence fee (rent) at the rate of 15% of the preceding month's rate after every three years.

v) Physical possession of the shop shall be handed over to the successful bidders. In case the selected bidder does not take possession of the allotted premises within one month, the shop shall be offered to next bidder(s).
